 more parents.

How will the school inform parents and family members about the Title I program?

- The school will inform parents and family members about the Title I program during the annual district meeting in the fall. During the meeting on Wednesday, October 2, 2024 the following information was shared:

 - Assessments used to monitor students' growth
 - o Interventions used during support time
 - Strategies to use in the home to help reading growth
- Parents are informed of the Title I program through a phone call at the beginning of the year when students qualify for the program. They also receive a welcome letter with information prior to the start of Title I classes.

How will the school explain the curriculum, state standards, and assessments?

- Grade level curriculum was shared by the classroom teachers at the beginning of the year.
- Report cards are sent home every 9 weeks by the classroom teacher.
- Summary reports and progress monitoring graphs are sent home every 9 weeks by the Title I teachers. These reports also contain a written explanation to help parents analyze the data.
- Information on the district website shares what the individual grade levels are working on and expectations.
- All agendas and classroom expectations are posted on all Blackboard pages and can be accessed by students and parents.
- District book available that matches State Standards with Scope and Sequence of our HMH reading curriculum identifies what needs to be mastered at each level.

How will the school accommodate meeting requests?

- Fall and spring conferences are scheduled meetings available for all parents, however, parents are always able to request a meeting at the school or over the phone.
- MTSS (Well Check Process) is available upon parent or school request for concerns about a specific child.
